Financial Highlights



Standalone Q2 FY20

- ➢ Operating revenue increased by 20.66% to Rs.1161.12 crore.
- ➤ Total Revenue up by 17.96% to Rs.1218.01 crore.
- \blacktriangleright PBT increased by 9.34% to Rs.137.21 crore.
- \blacktriangleright PAT increased by 4.94% to Rs.87.70 crore.
- Core EBITDA has increased to 7.70% in Q2 FY20 as compared to 6.53% in Q2 FY19.
- Earnings per Share (EPS) increased to Rs.9.32 as compared to Rs.8.89 in corresponding period FY19.

Consolidated Q2 FY20

- Operating revenue increased by 26.43% to Rs.1237.36 crore.
- ➤ Total Revenue up by 22.20% to Rs.1268.07 crore.
- \blacktriangleright PBT increased by 2.07% to Rs.133.58 crore.
- EBITDA increased to Rs.159.66 crore in Q2 FY20 as compared to Rs.154.27 crore in Q2 FY20
- Core EBITDA has increased to 10.42% in Q2 FY20 as compared to 9.73% in Q2 FY19.
